Electric Rates Effective Jul 2, 2016

RESIDENTIAL SERVICE RG-1

This rate will be applied to residential single-phase customers for ordinary household purposes.

Customer Fee single phase: \$11.75

Three phase: \$19.00

Energy Charge: \$.1005/kwh plus PCAC*

Minimum monthly fee will be the customer fee.

RESIDENTIAL SERVICE RG-2

(Optional Time-of-Day Service)

This rate is optional to all RG-1 Residential Service customers. Once a customer begins service on this rate schedule, the customer must remain on this schedule for one year.

(See Time-of-Day peak periods)**

Customer Fee single phase: \$11.75

Three phase: \$19.00

Energy Charge: \$.1760/kwh on peak

\$.0560/kwh off peak

plus PCAC* per kwh

Minimum monthly fee will be the customer fee.

GENERAL SERVICE GS-1

This rate will be applied to single and three phase customers. This includes commercial, institutional, government, and other customers. The monthly Maximum Measured Demand of customers on this rate shall not exceed 40 kilowatts for three or more months in a consecutive 12-month period.

Customer Fee single phase: \$11.75

Three phase: \$19.00

Energy Charge: \$.1020/kwh plus PCAC*

Minimum monthly fee will be the customer fee.

***Power Cost Adjustment PCAC**

PCAC provides a monthly adjustment of power costs relative to base rates. The adjustment can be positive or negative, which will increase or decrease your monthly energy costs.

GENERAL SERVICE GS-2

(Optional Time-of-Day Service)

This rate is optional to all GS-1 General Service customers. Once a customer begins service on this rate schedule, the customer must remain on this schedule for one year.

(See Time-of-Day peak periods)**

Customer Fee single phase: \$11.75

Three phase: \$19.00

Energy Charge: \$.1760/kwh on peak

\$.0560/kwh off peak

plus PCAC* per kwh

Minimum monthly fee will be the customer fee.

SMALL POWER CP-1

This rate will be applied to customers for all service types if their Maximum Measured Demand is between 40 kilowatts and 200 kilowatts per month for three or more months in a consecutive 12-month period.

Customer Fee: \$50.00

Distribution Demand: \$1.25/kw on 12-mon max

Demand Charge: \$7.30/kw on monthly max

Energy Charge: \$.0710 /kwh

Energy Limiter: \$.1224/kwh

plus PCAC* per kwh

The customer shall be billed monthly the lesser of 1) the amount of the Energy Limiter, and 2) the amount of the Energy Charge plus the amount of the Demand Charge.

Minimum monthly fee will be the customer fee plus the Distribution Demand.

SMALL POWER CP-1 TOD (Optional Service)

This rate is optional to all CP-1 Small Power Service customers. Once a customer begins service on this rate schedule, the customer must remain on this schedule for one year.

(Time-of-Day peak period 8:00am-8:00pm)

Customer Fee: \$50.00

Distribution Demand: \$1.25/kw on 12-mon max

Demand Charge: \$7.30/kw on monthly max

On-Peak Energy Charge: \$.1040 /kwh

Off-Peak Energy Charge: \$.0500/kwh

plus PCAC* per kwh

Minimum monthly fee will be the customer fee plus the Distribution Demand.

LARGE POWER TOD CP-2

This rate will be applied to customers for all service types if their Maximum Measured Demand is between 200 kilowatts and 1000 kilowatts per month for three or more months in a consecutive 12-month period. (See Time-of-Day peak periods)**

Customer Fee: \$200.00

Distribution Demand: \$1.50/kw on 12-mon max

Demand Charge: \$8.60/kw on monthly max

On-Peak Energy Charge: \$.0740 /kwh

Off-Peak Energy Charge: \$.0509/kwh

plus PCAC* per kwh

Minimum monthly fee will be the customer fee plus the Distribution Demand.

INDUSTRIAL POWER TOD CP-3

This rate will be applied to customers for all service types if their Maximum Measured Demand is over 1000 kilowatts per month for three or more months in a consecutive 12-month period.

(See Time-of-Day peak periods)**

Customer Fee: \$250.00

Distribution Demand: \$1.50/kw on 12-mon max

Demand Charge: \$10.60/kw on monthly max

On-Peak Energy Charge: \$.0720 /kwh

Off-Peak Energy Charge: \$.0500/kwh

plus PCAC* per kwh

SUMMER SEWER AVERAGING

Per Municipal Ordinance 13.12.300, Residential sewer customers will pay sewer charges based on the water meter usage for the billing months of October to May. For the billing months of approximately June to September, Residential customer's monthly sewer charges will be capped to the monthly average, plus 10%, of the period October to May billings. The Summer Sewer Average period effective dates will be determined by each property's respective scheduled meter reading dates. Watch your monthly billings for specific dates. STORM WATER UTILITY 825-1170

Storm Water is generally rain and melting snow that runs off surfaces that cannot readily absorb water (impervious surfaces). The City of Sun Prairie began a federally mandated program funded by a storm water fee levied on all citizens and businesses. Fees are based on Equivalent Runoff Unit (ERU). The rate for 1 ERU is currently set by City Council at \$10.20. Single residence=1 ERU, Duplex=.65 ERU, multi-family=.40 ERU, commercial is based on the impervious area of a specific property.
